#### **Extent**

75 folders

#### Access

Collection is open to all researchers. Access to Bush Presidential Records, Bush Vice Presidential Records, and Quayle Vice Presidential Records is governed by the Freedom of Information Act (FOIA)(5 USC 552 as amended) and the Presidential Records Act (PRA)(44 USC 22) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

### Copyright

Documents in this collection that were prepared by officials of the United States government as part of their official duties are in the public domain. Researchers are advised to consult the copyright law of the United States (Title 17, USC) which governs the making of photocopies or other reproductions of copyrighted material.

#### Provenance

Official records of George Bush's presidency and vice presidency are housed at the George Bush Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

#### **Processed By**

Staff Archivists, March 1998. Previously restricted materials are added as they are released.

### **Scope and Content**

The materials in FOIA 1998-0095-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 1998-0095-F contains material related to the Bush administration's policy on homosexuals. This includes the treatment of lesbians and gay men in the military, federal government, and by society in general. A substantial portion of this subject collection deals with the administration's position on the Hate Crime Statistics Bill which required law enforcement agencies to collect data on crimes committed

due to hatred of a person's race, gender, religion, ethnicity, and sexual orientation. The material in this FOIA includes published articles, reports, memoranda, and correspondence between the general public, Congress, federal agencies, and the White House.

The White House Office of Records Management (WHORM) Alphabetical Files contain letters from the general public concerning individuals and families concerning homosexuality and society.

The WHORM Subject File categories contain correspondence; memoranda; news clippings; and brochures from the general public, Congress, and the Bush administration. These files primarily deal with support or opposition to various issues related to homosexuality, including several organizations, groups and educational institutions and their policies regarding homosexuals. These files also include materials related to the Hate Crimes Statistics Act and the Bush administration's meeting with various groups to discuss homosexuality.

The Staff and Office Files contain correspondence, memoranda, news clippings, and petitions. They pertain to the issue of homosexuality in the Hate Crimes Statistics Bill, an incident involving FEMA, students and the military, and the campaign of 1992.

### **System of Arrangement**

Records that are responsive to this FOIA request were found in four collection areas—Bush Presidential Records: WHORM Alphabetical Files; Bush Presidential Records: WHORM Subject Files; Bush Presidential Records: Staff and Office Files; and Quayle Vice Presidential Records: Staff and Office Files. As policy, WHORM Alphabetical Files and WHORM Subject Files are processed at the document level; whereas, Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of documents assigned a letter/number combination and filed in a subject category.
