Access

Collection is open to all researchers. Access to Bush Presidential Records is governed by the Freedom of Information Act (FOIA)(5 USC 552 as amended) and the Presidential Records Act (PRA)(44 USC 22) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

Copyright

Documents in this collection that were prepared by officials of the United States government as part of their official duties are in the public domain. Researchers are advised to consult the copyright law of the United States (Title 17, USC) which governs the making of photocopies or other reproductions of copyrighted material.

Provenance

Official records of George Bush's presidency are housed at the George Bush Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

Processed By

Staff Archivists, September 1998. Previously restricted materials are added as they are released.

Scope and Content

The materials in FOIA 1998-0253-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 1998-0253-F contains correspondence between various individuals, mostly public officials from the national, state, and local levels of government, and the Bush administration. The vast majority of documents in this request are located in the White House Office of Records Management (WHORM) Subject File. Much of the material from U.S. senators and representatives sent to the White House

consists of letters to President Bush signed by any number of members of Congress on a wide range of foreign and domestic topics, including constituent correspondence that was passed along to the White House. There is no substantive correspondence directly between President Bush and these senators and representatives. The Office of Legislative Affairs was responsible for routing this correspondence to the appropriate department or official so a suitable response could be drafted.

A minority of these records are from state and local government officials. This correspondence was handled by the Office of Intergovernmental Affairs and most often related to issues of federal funding provided to state and local government entities. Again, there was virtually no correspondence between President Bush and these officials.

System of Arrangement

Records that are responsive to this FOIA request were found in seven collection areas—Bush Presidential Records: WHORM Alphabetical Files; Bush Presidential Records: WHORM Subject Files; and Bush Presidential Records: Staff and Office Files. As policy, WHORM Alphabetical Files and WHORM Subject Files are processed at the document level. Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of documents assigned a letter/number combination and filed in a subject category. A complete listing of the subject categories including a detailed description of each category is available in our research room and on our website at <http://bushlibrary.tamu.edu/research/find/whorm/whorm.html>.

This finding aid is divided alphabetically by last name. Many documents, because they were signed by numerous members of Congress, are relevant to more than one case. In these instances, the documents are listed under each name where appropriate. In the case of fifteen of the thirty-five people included in this FOIA request, no documents were located. In many instances, these were officials elected to government service at the end of or after the Bush administration. Those names are:
