Scope and Content

The materials in FOIA 1998-0356-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 1998-0356-F contains information on S&L's (savings and loans) and the Bush Administration's plan for resolving the crisis that developed in the S&L industry during the 1980's. Richard Breeden's staff files contain congressional, lender, and constituent correspondence together with White House and Administration memoranda concerning the Thrift Restructuring Bill, QTL (qualified thrift lender test), background on banking problems, Congressional testimony, and credit union and thrift industry views on S&L restructuring. Subject File FG134 (Federal Home Loan Bank Board) contains information of resignations and appointments to the federal Home Loan Bank Board, Freddie Mac Board, and Housing Finance Board, proposed S&L bailout plans, Congressional testimony concerning S&L's, and Congressional correspondence concerning appointments and oversight of various financial boards.

System of Arrangement

Records that are responsive to this FOIA request were found in two collection areas—Bush Presidential Records: WHORM Subject Files; and Bush Presidential Records: Staff and Office Files. As policy, WHORM Alphabetical Files and WHORM Subject Files are processed at the document level. Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of documents assigned a letter/number combination and filed in a subject category. A complete listing of the subject categories including a detailed description of each category is available in our research room and on our website at <http://bushlibrary.tamu.edu/research/find/whorm/whorm.html>.

Please note that a single asterisk "*" indicates that the category is entirely processed and open. Please also note that a "***" indicates files or documents that were incidentally processed as part of this FOIA request.
