Provenance

Official records of George Bush's presidency and vice presidency are housed at the George Bush Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

Processed By

Staff Archivists, October 1998. Previously restricted materials are added as they are released.

Scope and Content

The materials in FOIA 1998-0381-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 1998-0381-F contains information on Doug Wead who served as Special Assistant to the President for Public Liaison and liaison with the Evangelical Christian Community. The Subject and Alphabetical files contain correspondence from constituents and Congress concerning personal problems and both

foreign and domestic religious issues. Issues include discrimination against Christians in the United States and persecution of Christians in foreign countries especially El Salvador. The Staff and Office Files include memoranda between Doug Wead and Andrew Card, John Sununu, President Bush, Lee Atwater, Marlin Fitzwater, Bill Phillips, and Ron Kaufman. The Bush Vice Presidential Staff and Office Files include several memoranda and strategy papers from Doug Wead outlining Vice President Bush's strategy with the Evangelical Community during 1985 and 1986.

There are two groups of records that may be of special interest to researchers; first, the public mail received by Andrew Card after the departure of Doug Wead from the White House staff in August 1990, and second, Doug Wead's Alphabetical files. These files contain mail from the general public and conservative leaders concerning Christian issues in the United States. Topics include the National Endowment for the Arts, appointments to office, abortion, gay and lesbian issues, and evangelical meetings with President Bush.

System of Arrangement

Records that are responsive to this FOIA request were found in four collection areas—Bush Presidential Records: WHORM Alphabetical Files; Bush Presidential Records: WHORM Subject Files; Bush Presidential Records: Staff and Office Files; and Bush Vice Presidential Records: Staff and Office Files. As policy, WHORM Alphabetical Files and WHORM Subject Files are processed at the document level. Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of documents assigned a letter/number combination and filed in a subject category. A complete listing of the subject categories including a detailed description of each category is available in our research room and on our website at <http://bushlibrary.tamu.edu/research/find/whorm/whorm.html>.

Please note that a single asterisk "*" indicates that the category is entirely processed and open.
