# Provenance

Official records of George Bush's presidency and vice presidency are housed at the George Bush Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

# Processed By

Staff Archivists, January 1999. Previously restricted materials are added as they are released.

# Scope and Content

The materials in FOIA 1999-0099-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 1999-0099-F contains materials on Caspar Weinberger. The Presidential WHORM Subject File contains general correspondence and unsolicited advice from Mr. Weinberger in his capacity as publisher of Forbes Magazine and Chairman of the USA-ROC Economic Council. The Vice Presidential WHORM Subject File contains correspondence between Vice President Bush and Caspar Weinberger in his capacity

as Secretary of Defense. The bulk of this material consists of invitations to various military events sponsored by the Department of Defense. The Presidential Staff and Office Files contain information on President Bush's pardon of Caspar Weinberger and background material on Iran-Contra including indictments, testimony, and newspaper articles. The Staff and Office Files also contain information on Caspar Weinberger's personal papers and a discussion of access to those papers by Independent Council Lawrence Walsh.

#### System of Arrangement

Records that are responsive to this FOIA request were found in five collection areas—Bush Presidential Records: WHORM Alphabetical Files; Bush Presidential Records: WHORM Subject Files; Bush Presidential Records: Staff and Office Files; Bush Vice Presidential Records: Staff and Office Files and Quayle Vice Presidential Records: Staff and Office Files. As policy, WHORM Alphabetical Files and WHORM Subject Files are processed at the document level. Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of documents assigned a letter/number combination and filed in a subject category. A complete listing of the subject categories including a detailed description of each category is available in our research room and on our website at <a href="http://bushlibrary.tamu.edu/research/find/whorm/whorm.html">http://bushlibrary.tamu.edu/research/find/whorm.html</a>.

Please note that a single asterisk "\*" indicates that the category is entirely processed and open.
