Access

Access to Bush Presidential Records, Bush Vice Presidential Records, and Quayle Vice Presidential Records is governed by the Freedom of Information Act (FOIA)(5 USC 552 as amended) and the Presidential Records Act (PRA)(44 USC 22) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

Copyright

Documents in this collection that were prepared by officials of the United States government as part of their official duties are in the public domain. Researchers are advised to consult the copyright law of the United States (Title 17, USC) which governs the making of photocopies or other reproductions of copyrighted material.

Provenance

Official records of George Bush's presidency and vice presidency are housed at the George Bush Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

Processed By

Staff Archivists, January–March 1999. Previously restricted materials are added as they are released.

Scope and Content

The materials in FOIA 1999-0103-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 1999-0103-F material is divided into three primary categories: the Subject File, the Presidential Staff and Office Files, and Vice Presidential Staff and Office Files. Most of the material in the Subject File can be found in CO141, South Africa and TA001, Boycotts-Embargoes. CO141 contains Congressional and constituent correspondence on investment in South Africa, gold and precious metal mining, social

justice in South Africa, religious freedom in South Africa, and South African sanctions. TA001 contains correspondence from Congress, constituents, civic groups, and religious groups concerning trade sanctions against Japan, Cambodia, South Africa, the Soviet Union, Iraq, China, and Haiti. These materials include letters, executive orders, memoranda, briefing papers, and assorted background material concerning chemical weapons, trade, and nuclear nonproliferation issues.

The Presidential Staff and Office Files contains memos, letters, memos of conversation, telcons, and background papers on South Africa including information on the African National Congress (ANC), Nelson Mandela, F.W. de Klerk, Inkatha, Chief Gatsha Buthelezi, and the South African economy. Most of the files specifically relate to preparation for visits by Mandela, de Klerk, and Buthelezi during the critical transition away from apartheid in South Africa from 1989-1992.

The Vice Presidential Staff and Office Files contain background information on South Africa as well as biographies of important South African leaders such as P.W. Botha, Chief Gatsha Buthelezi, F.W. de Klerk, Dr. Nthanto Motlana, and Archbishop Desmond Tutu. The materials include intelligence analysis, biographies, policy memoranda, and correspondence between Congress and the Vice President and between the Vice President and his advisors regarding South African sanctions.

System of Arrangement

Records that are responsive to this FOIA request were found in three collection areas—Bush Presidential Records: WHORM Subject Files; Bush Presidential Records: Staff and Office Files; and Bush Vice Presidential Records: Staff and Office Files. As policy, WHORM Alphabetical Files and WHORM Subject Files are processed at the document level; whereas, Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of documents assigned a letter/number combination and filed in a subject category. A complete listing of the subject categories including a detailed description of each category is available in our research room and on our website at http://bushlibrary.tamu.edu/research/find/whorm/whorm.html.

Please note that a single asterisk "*" indicates that the category is entirely processed and open.
