## **Scope and Content:**

The materials in FOIA 1999-0393-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 1999-0393-F contains correspondence and telephone conversations between President Bush and German Chancellor Helmut Kohl concerning the fall of the Berlin wall and the reunification of Germany. Most of the material responsive to this FOIA consists of Memoranda of Telephone Conversations between the President and Chancellor Kohl which took place between March 1989 and July 1990.

The WHORM Subject File categories contain correspondence, memoranda of conversations, and material related the various forms of correspondence between President George H. W. Bush and Chancellor Helmut Kohl of Germany.

The Staff and Office Files contain correspondence, memoranda of conversations (memcons), and memoranda of telephone conversations (telcons) between President George H. W. Bush and Chancellor Helmut Kohl of Germany.

**System of Arrangement** [Identifies the various groups of archival materials, their relationships, or the sequence of documents within them.]

**EXAMPLE:** Records that are responsive to this FOIA request were found in two collection areas—Bush Presidential Records: WHORM Subject Files; Bush Presidential Records: Staff and Office Files. As policy, WHORM Alphabetical Files and WHORM Subject Files are processed at the document level; whereas, Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of documents assigned a letter/number combination and filed in a subject category. A complete listing of the subject categories including a detailed description of each category is available in our research room and on our website at <a href="http://bushlibrary.tamu.edu/research/find/whorm/whorm.html">http://bushlibrary.tamu.edu/research/find/whorm/whorm.html</a>.

Please note that a single asterisk "\*" indicates that the category is entirely processed and open.
