#### **Extent**

71 folders

#### **Access**

Collection is open to all researchers. Access to Bush Presidential Records, Bush Vice Presidential Records, and Quayle Vice Presidential Records is governed by the Freedom of Information Act (FOIA)(5 USC 552 as amended) and the Presidential Records Act (PRA)(44 USC 22) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

#### **Copyright**

Documents in this collection that were prepared by officials of the United States government as part of their official duties are in the public domain. Researchers are advised to consult the copyright law of the United States (Title 17, USC) which governs the making of photocopies or other reproductions of copyrighted material.

#### **Provenance**

Official records of George Bush's presidency and vice presidency are housed at the George Bush Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

#### **Processed By**

Staff Archivists, April 2000. Previously restricted materials are added as they are released.

#### **Scope and Content**

The materials in FOIA 1999-0467-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 1999-0467-F contains materials pertaining to political, military, and diplomatic developments in El Salvador during the late 1980s and early 1990s. During this period, a peace accord was reached between the Salvadoran government and insurgents belonging to the FMLN (Farabundo Marchti National Liberation Front), ending over a Decembrace of civil strife.

White House Office of Records Management (WHORM) Subject Categories contain correspondence, memoranda, news clippings, and brochures from the general public, Congress, and the Bush administration. WHORM Subject File CO046 concerns the country of El Salvador, including memoranda, cables, and correspondence related to the peace process.

The Staff and Office Files contain correspondence, memoranda, and publications maintained by individual staff members and offices. These materials deal with the investigation of human rights violations, Nicaraguan support for the FMLN, and US economic and military assistance to El Salvador.

The Bush Vice Presidential Staff and Office Files contain correspondence, memoranda, and publications maintained by individual staff members and offices. The Donald P. Gregg Files of the Office of National Security Affairs addresses various threats ranging from natural disasters and terrorist death squads within El Salvador.

The Quayle Vice Presidential Staff and Office Files contain various speeches given by Vice President Quayle on the topic of El Salvador.

### **System of Arrangement**

Records that are responsive to this FOIA request were found in four collection areas—Bush Presidential Records: WHORM Subject Files; Bush Presidential Records: Staff and Office Files; Bush Vice Presidential Records: Staff and Office Files; and Quayle Vice Presidential Records: Staff and Office Files. As policy, WHORM Alphabetical Files and WHORM Subject Files are processed at the document level; whereas, Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of documents assigned a letter/number combination and filed in a subject category. A complete listing of the subject categories including a detailed description of each category is available in our research room and on our website at <http://bushlibrary.tamu.edu/research/find/whorm/whorm.html>.

Please note that a single asterisk "\*" indicates that the category is entirely processed and open.
