Copyright

Provenance

Official records of George Bush's presidency and vice presidency are housed at the George Bush Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

Processed By

Staff Archivists, May 2000. Previously restricted materials are added as they are released.

Scope and Content

The materials in FOIA 1999-0733-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 1999-0733-F contains select folders from the files of Daniel Casse, a staff member in the office of Cabinet Affairs. Correspondence files processed for this request contain material related to the daily activities and duties of Casse and cover a broad range of topics. The remaining processed files focus

more specifically on Casse's duties regarding federal assistance response to domestic disasters.

System of Arrangement

Records that are responsive to this FOIA request were found in one collection area—Bush Presidential Records: WHORM Subject Files. As policy, WHORM Alphabetical Files and WHORM Subject Files are processed at the document level. Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of documents assigned a letter/number combination and filed in a subject category. A complete listing of the subject categories including a detailed description of each category is available in our research room and on our website at <u>http://bushlibrary.tamu.edu/research/find/whorm/whorm.html</u>.

Please note that a single asterisk "*" indicates that the category is entirely processed and open.
