FOIA 2000-1206-F contains documents related to Fang Lizhi, the Chinese scientist that sought refuge (along with his wife Li Shuxian) in the American Embassy in Beijing during the Tiananmen Square protests in June 1989.

White House Office of Records Management (WHORM) Subject File categories contain routine public correspondence and internal memoranda

The WHORM Alphabetical Files contain letters from the general public concerning Fang Lizhi, the Chinese scientist that sought refuge (along with his wife Li Shuxian) in the American Embassy in Beijing during the Tiananmen Square protests in June 1989.

The Staff and Office Files contain correspondence, memoranda, and publications maintained by individual staff members and offices. Although these files are listed, it should be noted that most of these documents are security classified and have been closed under the restrictions of the Freedom of Information Act.

### **System of Arrangement**

Records that are responsive to this FOIA request were found in three collection areas—Bush Presidential Records: WHORM Alphabetical Files; Bush Presidential Records: WHORM Subject Files; and Bush Presidential Records: Staff and Office Files. As policy, WHORM Alphabetical Files and WHORM Subject Files are processed at the document level; whereas, Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of documents assigned a letter/number combination and filed in a subject category.
