## Records on Moiseyev Visit and Conventional Forces in Europe

#### **Extent**

9 folders

#### **Access**

Collection is open to all researchers. Access to Bush Presidential Records, Bush Vice Presidential Records, and Quayle Vice Presidential Records is governed by the Freedom of Information Act (FOIA)(5 USC 552 as amended) and the Presidential Records Act (PRA)(44 USC 22) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

#### **Copyright**

Documents in this collection that were prepared by officials of the United States government as part of their official duties are in the public domain. Researchers are advised to consult the copyright law of the United States (Title 17, USC) which governs the making of photocopies or other reproductions of copyrighted material.

#### **Provenance**

Official records of George Bush's presidency and vice presidency are housed at the George Bush Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

#### **Processed By**

Staff Archivists, September 2002. Previously restricted materials are added as they are released.

#### **Scope and Content**

The materials in FOIA 2000-1389-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2000-1389-F contains materials relating to negotiations and meetings concerning Conventional Forces in Europe (CFE) which took place in March 1991, May 1991, and June 1991, and the related meeting between President Bush and USSR General Moiseyev on May 20, 1991.

The Staff and Office Files contain cover pages, cover memos, transmittal forms, cover notes, press guidance, correspondence, participant lists, schedule proposals, and press reports. Cover pages, cover memos, and transmittal forms are from the White House, NSC, or the State Department. Cover notes, by White House personnel, describe the routing procedures to be followed in sending a document. The press guidance provides White House staff with guidance in answering questions about the visit of General Moiseyev and the CFE negotiations. The correspondence is from a member of congress concerning the CFE negotiations. The participant lists and schedule proposals concern the meeting between President Bush and General Moiseyev on May 20, 1991. The press report is an AFP report on the CFE negotiations. All of this material is from the National Security Council files of John Gordon and Heather Wilson. A significant amount of material responsive to this FOIA is contained in the files of the National Security Council (NSC). Although these files are listed, it should be noted that most of these documents are security classified and have been closed under the restrictions of the Freedom of Information Act.

### **System of Arrangement**

Records that are responsive to this FOIA request were found in one collection area—Bush Presidential Records: Staff and Office Files. As policy, WHORM Alphabetical Files and WHORM Subject Files are processed at the document level; whereas, Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of documents assigned a letter/number combination and filed in a subject category. A complete listing of the subject categories including a detailed description of each category is available in our research room and on our website at <http://bushlibrary.tamu.edu/research/find/whorm/whorm.html>.

Please note that a single asterisk "\*" indicates that the category is entirely processed and open.
