Provenance

Official records of George Bush's presidency and vice presidency are housed at the George Bush Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

Scope and Content

The materials in FOIA 2001-0010-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2001-0010-F contains materials related to Peru, specifically the last years of President Alan Garcia's administration (1985–1990) and the first years of President Alberto Fujimori's administration (1990–2000). During the Bush administration, Peru had issues of interest internationally: a presidential campaign; the downing of a U.S. C-130 aircraft; installation of new ambassadors to and from Peru

(Anthony C.E. Quainton and Roberto Guillermo MacLean); President Alberto Fujimori's U.S. visit; Fujimori's dissolution of the Peruvian constitution, Congress, and judiciary; as well as various meetings and programs to stimulate economic growth and eliminate the potential drug problems. This FOIA includes cables, charts, coversheets, fact sheets, letters, lists, memos, notes, press releases, printed materials, remarks/speeches, reports, schedules/agendas, statements, summaries, a telegram, a transcript, and vitas.

White House Office of Records Management (WHORM) Subject File category CO124 (Countries—The Republic of Peru) contains coversheets, memos, notes, letters, lists, speeches, and press releases. Coversheets consist of White House Correspondence Tracking Worksheets, Referral Sheets, Situation Room routing Slips, Staffing Memos, Action Data Summary reports, NSC Profile Reports and Routing slips, Presidential Correspondence routing forms, and State Department Transmittal Forms, all of which direct correspondence and/or other documents. The memos direct correspondence, outline presidential activities, and discuss speeches, press releases and drafts of letters. The notes are written regarding various correspondences. Letters are written regarding public views of U.S. aid to Peru and foreign investment in Peru; congressional correspondence expressing concern of U.S. support in Peru; congressmen referring constituent letters on various issues; and introducing correspondence. The list is a funding source for the Peru anti-narcotics initiative. The speeches and drafts are of George Bush's statement at the departure of Peru's President Fujimori on September 17, 1991. The press releases are for George Bush's offer of assistance in Peru against drug traffickers and his invitation to Peru President Alberto Fujimori to visit Washington, D.C. for an official working visit on September 17, 1991.

The Staff and Office Files are maintained by individual staff members within the office of the National Security Council and contain cables, a chart, coversheets, fact sheets/background information, letters, lists, memos, notes, press releases, printed material, remarks/speeches, reports, schedules/agendas, statements, summaries, a telegram, a transcript, and vitas. The cables contain a variety of information, such as Reuters news reports regarding the C-130, Peru Travel Advisory, and Peruvian President Fujimori's address regarding Counter-Narcotics Umbrella Agreement. The chart is on U.S. Aid to Peru. The coversheets include various agencies' fax sheets; NSC Distribution, Profile, and Referral sheets; and White House routing and transmittal slips, all of which direct correspondence and/or other documents. The fact sheets give information or background on Peruvian issues, such as Cessna Aircraft efforts in Peru, assistance to Peru, and general maps of Peru. The letters are from of variety of sources, such as the general public, congressional leaders, and George Bush, and deal with numerous issues such as assistance to Peru, Andean Trade issues, the International Narcotics Control Act (INCA), suspension of democracy in Peru, and archaeological treasures. The lists are rosters of participants in a number of meetings, working groups, committees, or administrations. The memos refer to many different issues such as requests for appointments, legislative referrals on the Andean Strategy, the 9th Circuit Verdugo Decision, assistance to Peru, and importation of Peruvian archaeological treasures. The notes refer to attachments, comments on various memos, meeting times, or reports. The press releases cover subjects which include the plane crash in Peru, Anthony Quainton's appointment as Ambassador to the Republic of Peru, Japan's and the U.S.' statement on the dissolution of Peruvian Congress. Printed material is comprised of a number of published articles, books, monthly bulletins, newspaper accounts, etc., which address subjects such as the Constitution of Peru, narcotics, U.S. aid to Peru, human rights, and the drug war, and various anti-government resistance groups. The remarks/speeches include President Bush's remarks upon the departure of Peruvian President Fujimori after his visit to the U.S., Lawrence Eagleburger's statement at the OAS Meeting of Foreign Ministers on Peru, May 18, 1992, and remarks by both George Bush and President Fujimori in San Antonio, TX in February of 1992, among others. Reports include the ADHOC Query Report, Alternative Development Strategy and Projects, and CSIS Latin American Election Study Series: The 1990 Peruvian Elections. The schedules/agendas enumerate various meetings, the official working visit to Washington, D.C. of President Fujimori in September of 1991, the U.S. Delegation for Peru's CCD elections, as well as various staff members' daily activities. There are two statements: Organization of American States "Support for the restoration of democracy in Peru" and Peru's Economic Stabilization Program by Carlos Hurtado Miller, President of the Council of Minister and

Minister of Economy and Finance in Peru. The transcript is for the Bernard Aronson Press Conference on May 2, 1992. The vitas are for Rick Finley and Ambassador Robert MacLean.

System of Arrangement

Records that are responsive to this FOIA request were found in two collection areas—Bush Presidential Records: WHORM Subject Files; Bush Presidential Records: Staff and Office Files. As policy, WHORM Subject and WHORM Alphabetical Files are processed at the document level; whereas, Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of documents assigned a letter/number combination and filed in a subject category. A complete listing of the subject categories including a detailed description of each category is available in our research room and on our website at <http://bushlibrary.tamu.edu/research/find/whorm/whorm.html>.

Please note that a single asterisk "*" indicates that the category is entirely processed and open.
