# Records on Colombian President Gavaria's March 1991 Visit

#### **Extent**

19 folders

#### **Access**

Collection is open to all researchers. Access to Bush Presidential Records, Bush Vice Presidential Records, and Quayle Vice Presidential Records is governed by the Freedom of Information Act (FOIA)(5 USC 552 as amended) and the Presidential Records Act (PRA)(44 USC 22) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

#### Copyright

Documents in this collection that were prepared by officials of the United States government as part of their official duties are in the public domain. Researchers are advised to consult the copyright law of the United States (Title 17, USC) which governs the making of photocopies or other reproductions of copyrighted material.

### **Provenance**

Official records of George Bush's presidency and vice presidency are housed at the George Bush Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

#### **Processed By**

Staff Archivists, February 2004. Previously restricted materials are added as they are released.

#### Scope and Content

The materials in FOIA 2001-0145-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2001-0145-F contains materials regarding the visit of Colombian President Gaviria to the United States in March 1991.

White House Office of Records Management (WHORM) Subject File categories contain correspondence; memoranda; news clippings; and brochures from the general public, Congress, and the Bush administration. WHORM Subject File FG298 concerns the USIA, including personnel matters, budgets, polling data from foreign countries, and the US involvement in the 1992 World Exposition. WHORM Subject File FG298-01 contains material related to the Voice of America including personnel matters, Radio Marti, reduction of broadcasts, and VOA's role in the Serbo-Croatian dispute. Letters from Congress and the public as well as some internal memoranda are present.

The WHORM Alphabetical Files contain transcripts of Presidential remarks on the departure of President Gaviria. In addition to this is correspondence such as thank you letters for hospitality on the part of President Gaviria and for gifts on the part of President Bush. Memoranda of conversations between President Bush and President Gaviria have been withdrawn under the national security classified information restriction of both the Presidential Records Act and the Freedom of Information Act.

The Staff and Office Files contain published reports such as Department of State Bureau of Public Affairs "Background Notes" on Colombia, schedules of events occurring during President Gaviria's visit, information memoranda on subjects such as timing of events and transmittal of correspondence, correspondence from Mrs. Bush thanking Mrs. Gaviria for her visit/gift, and routine interoffice memoranda dealing with foreign travel approval.

The Quayle Vice Presidential Staff and Office Files contain memoranda such as transmittal of photographs from the meeting between Vice President Quayle and President Gaviria. Items such as talking points for the Vice President's meeting with President Gaviria have been withdrawn under the national security classified information restriction of both the Presidential Records Act and the Freedom of Information Act.

## **System of Arrangement**

Records that are responsive to this FOIA request were found in three collection areas—Bush Presidential Records: WHORM Subject Files; Bush Presidential Records: Staff and Office Files; and Quayle Vice Presidential Records: Staff and Office Files. As policy, WHORM Alphabetical Files and WHORM Subject Files are processed at the document level. Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of documents assigned a letter/number combination and filed in a subject category.
