The materials in FOIA 2001-1451-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2001-1451-F contains documents concerning Florentino "Tino" Duran. Mr. Duran served as the president of the National Association of Hispanic Publications and the editor of the Spanish-language newspapers *El Informado Hispano* (Fort Worth, Texas) and *La Prensa* (San Antonio, Texas). These materials include routine correspondence from Mr. Duran to President Bush, and responses from federal agencies and the White House.
