Access

Access to Bush Presidential Records, Bush Vice Presidential Records, and Quayle Vice Presidential Records is governed by the Freedom of Information Act (FOIA)(5 USC 552 as amended) and the Presidential Records Act (PRA)(44 USC 22) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

Scope and Content

The materials in FOIA 2001-1703-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

This request contains materials related to United States policy toward South Korea (ROK) as well as

trade/ economic, military, and diplomatic relations between the two countries. Also included are records pertaining to National Security Review 28 (NSR-28) which outlined U.S. strategy in regards to North Korea's (DPRK) nuclear weapons program.

A significant majority of the records in this request have been closed due to national security restrictions. These records will be added to the request if and when they are released.

White House Office of Records Management (WHORM) Subject File categories contain routine correspondence of congratulations and greetings between President Bush and foreign heads of state and officials; memoranda regarding POTUS meetings with South Korean officials in Washington, D.C. (including South Korean President Roh Tae Woo in October 1989 and June 1990); the Korean Fighter Program; the Driftnets Agreement of 1991; the 40th anniversary of the beginning of the Korean War; and speech drafts, cables, and planning materials for President Bush's trips to Asia (which included South Korea) in February 1989 and January 1992. Also included are South Korean government publications regarding trade with the U.S. and reports concerning democratic reforms in South Korea.

The Staff and Office Files contain published reports on U.S.-South Korean trade and economic relations; correspondence from South Korean family groups seeking information on family members in North Korea; presidential speeches/ drafts, departure and arrival statements, and toasts of POTUS during his trip to South Korea and other Asian countries in February 1989 and January 1992 as well as itineraries, schedules, meeting agendas, guest lists, routine memoranda, briefing books, and general travel and planning materials; letters from Republic of Korea political party members seeking meetings with POTUS; POTUS interviews with South Korean newspapers; letters from U.S. congressmen recommending keeping forces in South Korea; planning materials regarding U.S./ ROK annual military exercise Team Spirit; proclamations for Korean War Remembrance Day/ Korean War Memorial; congratulatory letters from South Korean leaders for Desert Storm victory; Republic of Korea Ministry of Trade publications; schedules and itinerary of visit of Roh Tae Woo to Washington in October 1989 and June 1990; and letters from Billy Graham to POTUS regarding his trip to North Korea. The collection also contains a large amount of materials from the National Security Council relating to the North Korean nuclear program (NSR-28) and how U.S. policy should react to such an eventuality.

The WHORM Alphabetical Files contain letters from the general public concerning requests for assistance locating or visiting family members in North Korea, economic sanctions against South Korea, seeking information on family members Missing in Action in North Korea, reparations from the Russian government for the families of the victims of Korean Airlines Flight 007 (which was shot down by a Soviet warplane in 1983) and a Korean national seeking a waiver for U.S. citizenship.

The Bush Vice Presidential WHORM Subject Files contain two folders containing a letter regarding a family member Missing in Action in North Korea and an invitation to President Bush to attend a Kennedy Center concert featuring a pianist whose father was killed in the shooting down of KAL 007.

The Bush Vice Presidential Staff and Office Files consist of records pertaining to Vice President Bush's trip to East Asia in April and May 1982. The materials include a large amount of cables and telegrams containing, schedules, itineraries, guest lists, logistical information, speeches, and general planning materials. (Also included are similar materials related to Mrs. Bush while on the same trips.) In addition, much of the materials include routine memoranda, speeches/ toasts, talking points, schedules, and background information for meetings between Vice President Bush and South Korean government and business officials visiting Washington, D.C.

The Bush Vice Presidential Name File consists of one letter from Roh Tae Woo thanking VP Bush for the hospitality he and the South Korean delegation received while visiting Washington, D.C. in 1987.

The Quayle Vice Presidential Records consist of cables, schedules, itineraries, speeches/ drafts, and

routine memoranda pertaining to the Vice President's trip to Korea, Japan, Philippines, and Malaysia in 1989 (as well as his attendance at the International Democratic Union Conference during the same trip) and similar materials related to his meetings with South Korean government officials (mainly President Roh Tae Woo) in Washington, D.C. in 1990 and 1991.

System of Arrangement

Records that are responsive to this FOIA request were found in seven collection areas—Bush Presidential Records: WHORM Subject Files; Bush Presidential Records: WHORM Staff and Office Files; Bush Presidential Records: Alphabetical Files; Bush Vice Presidential Records: WHORM Subject Files; Bush Vice Presidential Records: Staff and Office Files; Bush Vice Presidential Records: Alphabetical Files; and Quayle Vice Presidential Records: Staff and Office Files. As policy, Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. WHORM Subject and WHORM Alphabetical Files are processed at the document level. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of documents assigned a letter/number combination and filed in a subject category. A complete listing of the subject categories including a detailed description of each category is available in our research room and on our website at <http://bushlibrary.tamu.edu/research/find/whorm/whorm.html>.

Please note that a single asterisk "*" indicates that the category is entirely processed and open.
