Access

Collection is open to all researchers. Access to Bush Presidential Records, Bush Vice Presidential Records, and Quayle Vice Presidential Records is governed by the Freedom of Information Act (FOIA)(5 USC 552 as amended) and the Presidential Records Act (PRA)(44 USC 22) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

Copyright

Documents in this collection that were prepared by officials of the United States government as part of their official duties are in the public domain. Researchers are advised to consult the copyright law of the United States (Title 17, USC) which governs the making of photocopies or other reproductions of copyrighted material.

Provenance

Official records of George Bush's presidency and vice presidency are housed at the George Bush Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

Processed By

Staff Archivists, March 2002. Previously restricted materials are added as they are released.

Scope and Content

The materials in FOIA 2001-2005-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2001-2005-F contains incoming letters, memoranda, invitations, and routine White House correspondence tracking forms. Letters and a memorandum concerning the request for Mrs. Johnson to sign a letter of support for President Bush's tree initiative are in this collection. The collection also includes an invitation for President and Mrs. Bush to attend a reception at the Lyndon Baines Johnson

Library honoring the marriage of Mr. and Mrs. Philip Chase Bobbitt. There is correspondence between officials at the University of Texas and Vice President Bush concerning an invitation for the Vice President to serve as honorary co-chairman of the Steering Committee for the Walter Cronkite roast with Mrs. Johnson. Also included in this collection of records are copies of photographs taken of Mrs. Johnson at the White House with President and Mrs. Bush. The correspondence tracking forms contain routine information such as the correspondent's name, the subject and the date of receipt of correspondence.

System of Arrangement

Records that are responsive to this FOIA request were found in five collection areas—Bush Presidential Records: WHORM Alphabetical Files; Bush Presidential Records: WHORM Subject Files; Bush Presidential Records: Staff and Office Files; Bush Vice Presidential Records: Name Files; Bush Vice Presidential Records: WHORM Subject Files. As policy, WHORM Alphabetical Files and WHORM Subject Files are processed at the document level. Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of documents assigned a letter/number combination and filed in a subject category. A complete listing of the subject categories including a detailed description of each category is available in our research room and on our website at <http://bushlibrary.tamu.edu/research/find/whorm/whorm.html>.

Please note that a single asterisk "*" indicates that the category is entirely processed and open.
