Access

Collection is open to all researchers. Access to Bush Presidential Records, Bush Vice Presidential Records, and Quayle Vice Presidential Records is governed by the Freedom of Information Act (FOIA)(5 USC 552 as amended) and the Presidential Records Act (PRA)(44 USC 22) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

Copyright

Documents in this collection that were prepared by officials of the United States government as part of their official duties are in the public domain. Researchers are advised to consult the copyright law of the United States (Title 17, USC) which governs the making of photocopies or other reproductions of copyrighted material.

Provenance

Official records of George Bush's presidency and vice presidency are housed at the George Bush Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

Scope and Content

The NEA is an independent Federal agency, created by Congress in 1965 to encourage and support American arts and artists. Its mission is to foster the excellence, diversity, and vitality of the arts in the United States and to help broaden their availability and appreciation. To fulfill this mission, the Endowment receives annual appropriations from the Congress from which it awards matching grants to nonprofit, tax-exempt arts organizations of outstanding quality and fellowships to artists of exceptional talent. The Arts Endowment is directed by a chairman and advised by the National Council on the Arts, a

presidential appointed body composed of the Endowment chairman and 26 distinguished citizens who are widely recognized as artists or experts in the arts.

The materials in FOIA 2002-0243-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2002-0243-F contains letters, reports, press releases, fact sheets, invitations, and other printed material. The reports in these records include demographic reports concerning artist employment, its affect on the economy, and public participation in the arts. There are also copies of the final report of the Independent Commission to Review NEA Grant Making Procedures. The press releases are from the White House and the NEA announcing appointments to the National Council on the Arts, Medal of Art recipients, and Design Award winners. The fact sheets describe NEA grant recipients and projects receiving federal funds. Invitations to events such as the National Heritage Fellowship Awards and the National Medal of Arts Recipients Dinner are part of this collection. Also included in these records are written testimony and transcripts of hearings before congressional committees concerning federal funding of the arts.

White House Office of Records Management (WHORM) Subject File categories contain correspondence; memoranda; news clippings; and brochures from the general public, Congress, and the Bush administration. Printed materials consist of newspaper articles and editorials concerning controversial exhibits funded by the NEA, the state of funding for the arts, possible candidates for the NEA chairmanship, and the performance of John Frohnmayer. These news clippings come from various publications such as *The Washington Times*, the *Los Angeles Times*, *The New Republic*, *USA Today*, the *Atlanta Constitution*, and *the Wall Street Journal*. There are also copies of remarks made by President Bush and John Frohnmayer and NEA publications such as "Arts in America 92," "Guide to the National Endowment for the Arts," and "Presidential Design Awards 1988."

The WHORM Alphabetical Files contain public and congressional mail in support of or in opposition to the NEA and the Endowment's reauthorization. Several arts organizations such as Dance/USA, The American Choral Directors Association, the Corcoran Gallery and religious groups such as the National Association of Evangelicals, the Christian Action Network, and The Christian Life Commission of the Southern Baptist Convention wrote President Bush and NEA Chairman John Frohnmayer regarding the inclusion of restrictive language concerning the content of NEA-funded projects in the Endowment's reauthorization legislation. Many of these letters express displeasure over specific artwork they found offensive such as Andres Serrano's art exhibition featuring Christian icons submerged in jars of urine, David Wojnarowicz's exhibit and catalog "Tongues of Flames," and Robert Mapplethorpe's photo exhibit containing homoerotic images. Also included in this collection are unsolicited recommendations for presidential appointments to the National Council for the Arts and for chairman of the NEA. There are also petitions calling for the resignation of NEA chairman John Frohnmayer.

The Staff and Office Files contain correspondence, memoranda, and publications maintained by individual staff members and offices. The reports in these records include demographic reports concerning artist employment and its affect on the economy, and public participation in the arts. There are also copies of the final report of the Independent Commission to Review NEA Grant Making Procedures.

System of Arrangement

Records that are responsive to this FOIA request were found in three collection areas—Bush Presidential Records: WHORM Alphabetical Files; Bush Presidential Records: WHORM Subject Files; and Bush Presidential Records: Staff and Office Files. As policy, WHORM Alphabetical Files and WHORM Subject Files are processed at the document level; whereas, Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of documents assigned a letter/number combination and filed in a subject category. A complete listing of the subject categories including a detailed description of each category is available in our research room and on our website at <http://bushlibrary.tamu.edu/research/find/whorm/whorm.html>.

Please note that a single asterisk "*" indicates that the category is entirely processed and open.
