#### **Scope and Content**

The materials in FOIA 2003-0258-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

The bulk of FOIA 2003-0258-F contains materials from agencies and individuals from the Jewish community including the Simon Wiesenthal Center, B'nai B'rith International, the Council of Jewish Federations, Union of Councils for Soviet Jews, Max M. Fisher, and rabbis from around the United States. Other topics broached in FOIA 2003-0258-F include Syrian Jewry, foreign relations with Lebanon, the Los Angeles race riots of 1992 and President Bush's subsequent visits to the city, as well as agricultural and ethnic affairs, and the Housing and Urban Development (HUD) and Real Estate Settlement Procedures Act (RESPA).

The Staff and Office Files contain correspondence, memoranda, advance schedules and briefings, and publications, as well as presidential speeches, statements, and proclamations maintained by individual staff members and offices. The files within FOIA 2003-0258-F were maintained solely by Windy White, who worked at the White House from April 1992 until the end of the administration as Special Assistant to the Deputy Assistant to the President and Director of the Office of Public Liaison, Cecile B. Kremer—the Office's Jewish community liaison during the same period. As such, the majority of White's files should be considered more Kremer's than White's.

### **System of Arrangement**

Records that are responsive to this FOIA request were found in one collection area—Bush Presidential Records: Staff and Office Files. As policy, WHORM Alphabetical Files and WHORM Subject Files are processed at the document level; whereas, Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

FOIA 2003-0258-F consists of two series, subject files and chronological files. The subject files are processed according to the order in which the Bush Library received the materials from the White House. The chronological files are arranged chronologically by folder title. For the most part, the contents within the folders of this series are in reverse chronological order, but the researcher may find that, at times, this filing system was not always followed and documents may be misarranged.
