## Scope and Content

The materials in FOIA 2004-0623-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2004-0623-F contains materials related to Haroldson Lafayette "H.L." Hunt, Ray Lee Hunt, Hunt Oil Company, Yemen Hunt Oil Company, Sheikh Kamal Adham of Saudi Arabia, James Lilley, former Prime Minister of Yemen Abdul Karim El-Eryani, Hatem El-Khalidi, Arabian Shield Development Company.

White House Office of Records Management (WHORM) Subject File categories contain memoranda, schedules, reports, personnel records, and correspondence related primarily to James R. Lilley and his work as attaché to Taiwan, Ambassador to China, and Assistant Secretary of Defense (International Security Affairs).

The WHORM Alphabetical Files contain records related to James R. Lilley.

The Staff and Office Files contain correspondence tracking sheets, routine memoranda, routine correspondence, schedules/ schedule proposals, press releases, resumes, and personnel forms related to James R. Lilley, similar to those described above. The materials also include routine correspondence from private citizens commending Lilley on his job performance and correspondence from Ray Hunt regarding Hunt Oil Company's exploration of oil fields in North Yemen. In addition, a significant amount of the records relate to an investigation into the relationship between former White House advisor Ed Rogers and Sheikh Kamal Adham/ BCCI (Bank of Credit and Commerce International).

## System of Arrangement

Records that are responsive to this FOIA request were found in five collection areas—Bush Presidential Records: WHORM Subject Files; Bush Presidential Records: Staff and Office Files; Bush Vice Presidential Records: Name File; Bush Vice Presidential Records: Subject File; Bush Vice Presidential Records: Staff and Office Files. As policy, Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. WHORM Subject and WHORM Alphabetical Files are processed at the document level. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of documents assigned a letter/number combination and filed in a subject category. A complete listing of the subject categories including a detailed description of each category is available in our research room and on our website at <http://bushlibrary.tamu.edu/research/find/whorm/whorm.html>.

Please note that a single asterisk "\*" indicates that the category is entirely processed and open.
