#### Scope and Content

The materials in FOIA 2004-1019-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2004-1019-F contains materials from agencies and individuals regarding various aspects of baseball.

The Alphabetical Name File contains correspondence to and from individuals to the Vice President. The subject file contains correspondence; memoranda; news clippings; and brochures from the general public, Congress, and Vice President Bush's staff. Many of these documents are requests for the Vice President's autograph or are invitations to participate in activities that range from local little leagues to the major baseball franchises.

The Staff and Office Files contain correspondence, memoranda, and publications maintained by individual staff members and offices. Events such as ceremonies at the National Baseball Hall of Fame and the All Star Game of 1988 are covered in these files.

#### System of Arrangement

Records that are responsive to this FOIA request were found in seven collection areas—Bush Presidential Records: WHORM Alphabetical Files; Bush Presidential Records: WHORM Subject Files; and Bush Presidential Records: Staff and Office Files. As policy, WHORM Alphabetical Files and WHORM Subject Files are processed at the document level. Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of documents assigned a letter/number combination and filed in a subject category. A complete listing of the subject categories including a detailed description of each category is available in our research room and on our website at <a href="http://bushlibrary.tamu.edu/research/find/whorm/whorm.html">http://bushlibrary.tamu.edu/research/find/whorm.html</a>.

Please note that a single asterisk "\*" indicates that the category is entirely processed and open.
