FOIA 2004-1678-F contains materials the files of Donald P. Gregg in the Office of the National Security Agency. He served as National Security Advisor to Vice President George H.W. Bush during the Reagan Administration.

The selected National Security Agency files on Indonesia have to do with meetings for Vice President Bush with various officials related to Indonesia. These include:

May 1981 meeting with Indonesian Vice President Adam Malik
July 1982 meeting with Indonesian Defense Minister Mohammed Jusuf
October 1982 State visit of Indonesian President Soeharto
November 1984 meeting of U.S. Ambassador to Indonesia John Holdridge
July 1984 visit of Dr. B. J. Habibie, Minister of State for Research and Technology for the Republic of Indonesia

The Staff and Office Files contain schedules, dividers, memos, notes, and remarks.

These materials consist of schedules for the following visits of Indonesian officials to the United States: Vice President Malik (May 20-16, 1981), Dr. B. J. Habibie (July 9-11, 1984), and the State Visit of President Soeharto (October 10-15, 1982), as well as the dividers included in the schedule packets. Memos deal with Vice President Bush's meeting with Vice President Malik, a courtesy call to and the State Visit of President Soeharto, a 1984 meeting of U.S. Ambassador to Indonesia John Holdridge with Vice President Bush, as well as the forwarding of other correspondence in the White House; notes having to do with the State Visit; and President Reagan's remarks upon the arrival of and his White House toast to President Soeharto.

System of Arrangement

Records that are responsive to this FOIA request were found in one collection area—Bush Vice Presidential Records: Staff and Office Files. Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.
