Collection is open to all researchers. Access to Bush Presidential Records, Bush Vice Presidential Records, and Quayle Vice Presidential Records is governed by the Freedom of Information Act (FOIA)(5 USC 552 as amended) and the Presidential Records Act (PRA)(44 USC 22) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

Copyright

Documents in this collection that were prepared by officials of the United States government as part of their official duties are in the public domain. Provenance

Official records of George Bush's presidency and vice presidency are housed at the George Bush Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

Processed By

Scope and Content

The materials in FOIA 2005-0053-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2005-0053-F contains materials from the Office of the Vice President related to U.S. relations with the parties involved in the Soviet-Afghan War (1979-1989).

(A significant majority of the records in this request have been closed due to national security restrictions. These records will be added to the request if and when they are released.)

The Staff and Office Files contain cables, memoranda, public statements, press releases, reports, and options papers pertaining to events in Afghanistan following the evacuation of the Soviet military forces from that country in 1989 and the attempts to establish a permanent Afghani government. Also included are memoranda of conversation and schedules related to a meeting between a delegation of the Afghan Interim Government and Vice President Quayle in Washington, DC in the fall of 1991.

System of Arrangement

Records that are responsive to this FOIA request were found in one collection area—Quayle Vice Presidential Records: Staff and Office Files.

The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of documents assigned a letter/number combination and filed in a subject category.
