Collection is open to all researchers. Access to Bush Presidential Records is governed by the Freedom of Information Act (FOIA)(5 USC 552 as amended) and the Presidential Records Act (PRA)(44 USC 22) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

Copyright

Documents in this collection that were prepared by officials of the United States government as part of their official duties are in the public domain. Researchers are advised to consult the copyright law of the United States (Title 17, USC) which governs the making of photocopies or other reproductions of copyrighted material.

Provenance

Official records of George Bush's presidency and vice presidency are housed at the George Bush Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

Processed By

Staff Archivists, February – March 2010. Previously restricted materials are added as they are released.

Scope and Content

The materials in FOIA 2005-0135-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

The White House Office of Records Management (WHORM) Subject Files include correspondence, notes, memoranda, and schedules discussing routine correspondence, the sale of aircraft to Icelandair, the U.S. communications plan for the Reykjavik Summit, Vice President and Barbara Bush's trip to northern European countries, and a lunch at the White House in honor of Icelandic President Finnbogadottir.

The Staff and Office Files contain correspondence, schedules, cables, notes, and memoranda maintained by individual staff members and offices. Records from the Office of the Chief of Staff and Mrs. Bush's Office discuss the Iceland leg of the Vice President and Barbara Bush's trip to northern European countries. Records from the Office of National Security Affairs concern routine correspondence and requests, the visit of President Finnbogadottir to the United States, and a meeting with the U.S. Ambassador to Iceland.

System of Arrangement

Records that are responsive to this FOIA request were found in two collection areas: Bush Vice Presidential Records: WHORM Subject Files and Bush Vice Presidential Records: Staff and Office Files. As policy, WHORM Subject Files are processed at the document level. Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.
