#### **Scope and Content**

The materials in FOIA 2005-0335-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials. FOIA 2005-0335-F contains correspondence, vice presidential remarks, and agendas related to the vice president's participation in the swearing-in ceremony for PCAST members; printed material consisting of news articles about D. Allan Bromley's role as Science Advisor and Director of the Office of Science and Technology Policy (OSTP); press releases related to presidential remarks on global change; a press briefing by Bromley and his co-chairs of the White House Conference on Science and Economics Research Related to Global Change; a fact sheet on the science and technology accomplishments and initiatives of the Bush Administration; and an announcement of the PCAST members.

## **System of Arrangement**

Records that are responsive to this FOIA request were found in one collection area—Quayle Vice Presidential Records: Staff and Office Files. Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.
