Scope and Content

FOIA 2005-0394-F contains materials from the President's Foreign Intelligence Advisory Board (PFIAB), an independent body within the Executive Office of the President. PFIAB and its component the Intelligence Oversight Board (IOB) advised the President on foreign intelligence matters, to include the efficacy of the intelligence community's efforts and compliance with the Constitution, Executive Orders, and all applicable laws.

System of Arrangement
