#### **Extent**

#### Access

Collection is open to all researchers. Access to Bush Presidential Records, Bush Vice Presidential Records, and Quayle Vice Presidential Records is governed by the Freedom of Information Act (FOIA)(5 USC 552 as amended) and the Presidential Records Act (PRA)(44 USC 22) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

### Copyright

Documents in this collection that were prepared by officials of the United States government as part of their official duties are in the public domain. Researchers are advised to consult the copyright law of the United States (Title 17, USC) which governs the making of photocopies or other reproductions of copyrighted material.

#### **Provenance**

Official records of George Bush's presidency and vice presidency are housed at the George Bush Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

## **Processed By**

## **Scope and Content**

The materials in FOIA 2005-0440-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2005-0440-F contains materials regarding Robert K. Goodwin, who served as Executive Director of the President's Initiative for Historically Black Colleges and Universities starting in 1989. He became the Vice President of the Points of Light Foundation Board in 1992.

The Bush Presidential records contain letters, resumes, forms, memoranda, and articles related to Goodwin as Director of the White House Initiative on Historically Black Colleges and Universities and his

assumption of the Vice Presidency of the Points of Light Foundation Board. Included are letters of recommendation, copies of Goodwin's resume, copies of newspaper and magazine articles featuring Goodwin, and correspondence and memoranda dealing with conferences and agency funding, among other subjects.

The Bush Vice Presidential records consist of correspondence to and from Goodwin regarding potential employment and forwarding resumes of friends. Examples of newspapers published by Goodwin's family in Tulsa, Oklahoma, were also included.

## **System of Arrangement**

Records that are responsive to this FOIA request were found in four collection areas—Bush Presidential Records: WHORM Subject Files; Bush Presidential Records: WHORM Alphabetical Files; Bush Presidential Records: Staff and Office Files; and Bush Vice Presidential Records: Staff and Office Files. As policy, WHORM Subject and WHORM Alphabetical Files are processed at the document level, whereas Staff and Office Files are processed at the folder level; that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of documents assigned a letter/number combination and filed in a subject category. A complete listing of the subject categories including a detailed description of each category is available in our research room and on our website at <a href="http://bushlibrary.tamu.edu/research/find/whorm/whorm.html">http://bushlibrary.tamu.edu/research/find/whorm/whorm.html</a>.

Please note that a single asterisk "\*" indicates that the category is entirely processed and open.
