Copyright

Documents in this collection that were prepared by officials of the United States government as part of their official duties are in the public domain. Researchers are advised to consult the copyright law of the United States (Title 17, USC) which governs the making of photocopies or other reproductions of copyrighted material.

Provenance

Official records of George Bush's presidency and vice presidency are housed at the George Bush Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

Scope and Content

The materials in FOIA 2005-0445-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

These Staff and Office Files of C. Gregg Petersmeyer contain memoranda, correspondence, meeting agenda and minutes, news clippings, and printed material discussing national service activities and events. Notable topics include: printed material, memoranda, and correspondence between public service organizations and Petersmeyer concerning service events and activities; meeting minutes, agenda, and other materials for two meetings of the Board of the Directors of the Commission on National and Community Service; memoranda between Petersmeyer, President Bush, and White House staff concerning national service issues; and correspondence between President Bush and public citizens about service and volunteering.

System of Arrangement

Records that are responsive to this FOIA request were found in Bush Presidential Records: Staff and Office Files. As policy, Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.
