Official records of George Bush's presidency and vice presidency are housed at the George Bush Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

These Staff and Office Files contain memoranda, correspondence, plans, meeting minutes and agenda, directories, notes, biographical sketches, forms, and printed material discussing the Points of Light Foundation, and its plans and activities. Records from the First Lady Office concern a briefing of foundation leaders on the Points of Light Foundation by the Office of National Service and Foundation leaders. Files from the Office of National Service, the bulk of material in this FOIA request, discuss the Points of Light Foundation and its activities, leaders, relationship with the government and the Office of National Service, strategic plans, meetings, and issues. Also discussed are trips by Gregg Petersmeyer. Records from the Office of Personnel concern appointments to the President's Advisory Committee on the Points of Light Foundation Initiative. Records from the White House Social Office discuss Presidential luncheons with the Foundation board.

System of Arrangement

Records that are responsive to this FOIA request were found in Bush Presidential Records: Staff and Office Files. As policy, Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.
