Collection is open to all researchers. Access to Bush Presidential Records is governed by the Freedom of Information Act (FOIA) (5 USC 552 as amended) and the Presidential Records Act (PRA) (44 USC 22) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

Copyright

Documents in this collection that were prepared by officials of the United States government as part of their official duties are in the public domain. Researchers are advised to consult the copyright law of the United States (Title 17, USC) which governs the making of photocopies or other reproductions of copyrighted material.

Provenance

Official records of George Bush's presidency, his vice presidency and Dan Quayle's vice presidency are housed at the George Bush Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

Processed By

Staff Archivists, February 2010. Previously restricted materials are added as they are released.

Scope and Content

The materials in FOIA 2005-0575-F are responsive to the topic of the FOIA. This finding aid includes materials originally processed for FOIA 2005-0576-F "Bush Vice President Records on Libya" and FOIA 2005-0577-F "Quayle Vice President Records on Libya." Other related materials can be found in FOIAs 1998-0034-F and 1999-0131-F.

FOIA 2005-0575-F (including FOIA 2005-0576-F and FOIA 2005-0577-F) contains materials regarding the continued strained relationship between the United States and Libya following the downing of Pan Am 103. The Bush VP records include correspondence supporting or condemning the air strikes in 1986

while the Bush Presidential materials involve discussions on strategies that ultimately led to economic sanctions, UNSC involvement, and diplomatic efforts within the region and Europe in an effort to curb terrorism. This FOIA also contains materials related to the legal case presented to the International Court of Justice arguing Libya's culpability in the crash of Pan Am 103. Much of the material responsive to this FOIA is contained in the files of the National Security Council (NSC). Please note that although these files are listed, most of these documents are security classified and have been closed under the restrictions of the Freedom of Information Act.

System of Arrangement

Records that are responsive to this FOIA request were found in six collection areas—Bush Presidential Records: WHORM Alphabetical Files, WHORM Subject Files, and Staff and Office Files; Bush Vice Presidential Records: Subject File and Staff and Office Files; and Quayle Vice Presidential Records: Staff and Office Files. As policy, the WHORM and Subject (VP Bush) Files are processed at the document level. Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of documents assigned a letter/number combination and filed in a subject category. A complete listing of the subject categories including a detailed description of each category is available in our research room and on our website at http://bushlibrary.tamu.edu/research/find/whorm/whorm.html.

Please note that a single asterisk "*" indicates that the category is entirely processed and open.
