## Records on Visits of Boris Yeltsin to United States [Quayle Vice Presidential]

#### **Extent**

3 folders.

#### **Access**

Collection is open to all researchers. Access to Bush Presidential Records, Bush Vice Presidential Records, and Quayle Vice Presidential Records is governed by the Freedom of Information Act (FOIA)(5 USC 552 as amended) and the Presidential Records Act (PRA)(44 USC 22) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

#### **Copyright**

Documents in this collection that were prepared by officials of the United States government as part of their official duties are in the public domain. Researchers are advised to consult the copyright law of the United States (Title 17, USC) which governs the making of photocopies or other reproductions of copyrighted material.

#### **Provenance**

Official records of George Bush's presidency and vice presidency are housed at the George Bush Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

#### **Processed By**

Staff Archivists, May 2010. Previously restricted materials are added as they are released.

#### **Related Collections**

#### **Scope and Content**

The materials in FOIA 2005-1014-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2005-1014-F contains materials from the office of Vice President Quayle related to the visit of Russian President Boris Yeltsin to the United States for meetings with President Bush and the Vice President.

**(The majority of the records in this request have been closed due to national security restrictions. These records will be added to the request if and when they are released.)**

The Staff and Office Files contain pictorial biographies of the members of the Russian Delegation to the U.S., correspondence inviting Vice President Quayle to an award ceremony for Boris Yeltsin at the Center for Democracy, schedules related to the VP's attendance, and copies of remarks by VP Quayle and Yeltsin at the ceremony. Also included are memoranda of conversation, talking points, and other memoranda related to Yeltsin's meetings with Vice President Quayle.

### **System of Arrangement**

Records that are responsive to this FOIA request were found in one collection area—Quayle Vice Presidential Records: Staff and Office Files. As policy, Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.
