Access

Collection is open to all researchers. Access to Bush Presidential Records, Bush Vice Presidential Records, and Quayle Vice Presidential Records is governed by the Freedom of Information Act (FOIA)(5 USC 552 as amended) and the Presidential Records Act (PRA)(44 USC 22) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

Copyright

Documents in this collection that were prepared by officials of the United States government as part of their official duties are in the public domain. Researchers are advised to consult the copyright law of the United States (Title 17, USC) which governs the making of photocopies or other reproductions of copyrighted material.

Provenance

Official records of George Bush's presidency and vice presidency are housed at the George Bush Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

Processed By

Staff Archivists, July 2005. Previously restricted materials are added as they are released.

Scope and Content

The materials in FOIA 2005-1392-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2005-1392-F contains materials related to the nomination and appointment of John Glover Roberts, Jr. as Deputy Solicitor General (a position in which he served from 1989 until 1993) and his nomination to serve on the U.S. Court of Appeals for the District of Columbia (a position for which a Senate confirmation vote was never held).

White House Office of Records Management (WHORM) Subject File categories contain routine memoranda concerning Roberts' nomination, his resume, and newspaper and law journal articles written by or about Mr. Roberts.

The Staff and Office Files contain primarily correspondence related to resumes which were processed as part of FOIA 1998-0205-F (Presidential Appointment of Federal Judges); the majority of records specifically culled for this request are personnel records closed and/or redacted under FOIA exemption (b)(6).

System of Arrangement

Records that are responsive to this FOIA request were found in two collection areas—Bush Presidential Records: WHORM Subject Files and Bush Presidential Records: Staff and Office Files. As policy, WHORM Subject and WHORM Alphabetical Files are processed at the document level; whereas, Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of documents assigned a letter/number combination and filed in a subject category. A complete listing of the subject categories including a detailed description of each category is available in our research room and on our website at <http://bushlibrary.tamu.edu/research/find/whorm/whorm.html>.

Please note that a single asterisk "*" indicates that the category is entirely processed and open.
