Scope and Content

The materials in FOIA 2005-1502-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2005-1502-F consists of correspondence Daniel Marvin to President Bush regarding the visa application of General Dang Van Quang.

The WHORM Alphabetical File contains letters from Daniel Marvin to President Bush, dated 31 March

1989, regarding the visa application of General Dang Van Quang; and a letter from Daniel Marvin to President Bush, dated 17 July 1989, regarding the visa application of General Dang Van Quang. Accompanying each letter are the administration's response and correspondence tracking sheets.

System of Arrangement

Records that are responsive to this FOIA request were found in one collection area—Bush Presidential Records: WHORM Alphabetical Files. As policy, WHORM Alphabetical Files and WHORM Subject Files are processed at the document level; whereas, Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of documents assigned a letter/number combination and filed in a subject category.
