#### **Extent**

21 folders

#### **Access**

Collection is open to all researchers. Access to Bush Presidential Records, Bush Vice Presidential Records, and Quayle Vice Presidential Records is governed by the Freedom of Information Act (FOIA)(5 USC 552 as amended) and the Presidential Records Act (PRA)(44 USC 22) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

#### **Copyright**

Documents in this collection that were prepared by officials of the United States government as part of their official duties are in the public domain. Researchers are advised to consult the copyright law of the United States (Title 17, USC) which governs the making of photocopies or other reproductions of copyrighted material.

#### **Provenance**

Official records of George Bush's presidency and vice presidency are housed at the George Bush Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

#### **Processed By**

Staff Archivists, April 2009. Previously restricted materials are added as they are released.

#### **Scope and Content**

The materials in FOIA 2005-1620-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2005-1620-F contains materials relating to J. Michael Luttig, who served as Assistant Attorney General (Office of Legal Counsel) from 1990 to 1991. Luttig was subsequently nominated by President George H. W. Bush to be Judge of the Fourth Circuit Court of Appeals on April 23, 1991 and confirmed by the Senate on July 26, 1991.

The White House Office of Records Management (WHORM) Alphabetical Files contain the resume of J. Michael Luttig dated 1989.

The WHORM Subject File categories contain forms, memoranda, notes, and papers. These materials consist of papers analyzing legislation and correspondence regarding legal opinions from Luttig in his capacity as Assistant Attorney General on a variety of subjects, including allocation of expenses on political trips, recess appointments and nominations, nomination technicalities, legality of government actions, conflicts of interest, and the Hatch Act.

The Staff and Office Files contain forms, memoranda, notes, and resumes that consist of personnel files of J. Michael Luttig, including his appointment as Assistant Attorney General and as a Member of the President's Commission on the Federal Appointment Process.

### **System of Arrangement**

Records that are responsive to this FOIA request were found in three collection areas—Bush Presidential Records: WHORM Subject Files; Bush Presidential Records: WHORM Alphabetical Files; and Bush Presidential Records: Staff and Office Files. As policy, WHORM Subject and WHORM Alphabetical Files are processed at the document level; whereas, Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of documents assigned a letter/number combination and filed in a subject category. A complete listing of the subject categories including a detailed description of each category is available in our research room and on our website at <http://bushlibrary.tamu.edu/research/find/whorm/whorm.html>.

Please note that a single asterisk "\*" indicates that the category is entirely processed and open.
