#### **Scope and Content**

The materials in FOIA 2005-1659-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2005-1659-F contains materials from the National Security Council, specifically regarding Deputies Committee Meetings, and includes very basic and unclassified documents related to the humanitarian effort in Somalia during early fall of 1992. This material partially documents the efforts of the U.S. government, foreign governments, and worldwide non-governmental organizations, such as the International Committee of the Red Cross (CRC) and Save the Children. During the Bush administration, Rear Admiral Jonathan Howe represented the White House at the Deputies Committee Meetings regarding this effort in Somalia. The researcher should note that these files are limited to two very specific points in time and do not provide a comprehensive view of the crisis in Somalia or of the United States' response.

The Staff and Office Files contain a blank form, chart, list, and several memos and papers maintained by Rear Admiral Jonathan Howe, a staff member from the National Security Council. Admiral Howe's files contain a blank form, which was designed for security information; a chart which presents a timeline of deployment; a list to document participants in Deputies Committee Meetings; memos which route background papers on Somalia, as well as minutes and summaries of Deputies Committee Meetings; and papers which address humanitarian relief programs for Somalia and the plan for a conference on coordination of Somalian relief.

## **System of Arrangement**

Records that are responsive to this FOIA request were found in one collection area—Bush Presidential Records: Staff and Office Files. As policy, WHORM Alphabetical Files and WHORM Subject Files are processed at the document level; whereas, Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of documents assigned a letter/number combination and filed in a subject category.
