Documents in this collection that were prepared by officials of the United States government as part of their official duties are in the public domain. Provenance

Official records of George Bush's presidency and vice presidency are housed at the George Bush Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

Processed By

Staff Archivists, March 2008. Previously restricted materials are added as they are released.

Scope and Content

The materials in FOIA 2006-0348-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2006-0348-F contains tracking and referral sheets, notes, letters of correspondence, meeting attendee lists, resumes, and biographical sketches. The tracking and referral sheets and notes are of routine nature routing various letters of correspondence to staff members with sometimes brief descriptions of the particular topic. Letters primarily consist of non-sensitive head of state correspondence offering condolences to the United States in the wake of Hurricane Andrew. Other letters

come from interest groups requesting U.S. intervention and aid in Rwanda. Resumes and biographical sketches are related to members who were nominated and successfully appointed to ambassadorial positions in various African countries. Meeting attendee lists are related to a Policy Coordinating Committee meeting on Rwanda and Burundi in March 1992.

Records that are responsive to this FOIA request were found in two collection areas—Bush Presidential Records: WHORM Subject Files and Bush Presidential Records: Staff and Office Files. As policy, WHORM Subject Files are processed at the document level; whereas, Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of documents assigned a letter/number combination and filed in a subject category. A complete listing of the subject categories including a detailed description of each category is available in our research room and on our website at http://bushlibrary.tamu.edu/research/find/whorm/whorm.html.

Please note that a single asterisk "*" indicates that the category is entirely processed and open.
