Access to Bush Presidential Records, Bush Vice Presidential Records, and Quayle Vice Presidential Records is governed by the Freedom of Information Act (FOIA)(5 USC 552 as amended) and the Presidential Records Act (PRA)(44 USC 22) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

## Copyright

Documents in this collection that were prepared by officials of the United States government as part of their official duties are in the public domain. Researchers are advised to consult the copyright law of the United States (Title 17, USC) which governs the making of photocopies or other reproductions of copyrighted material.

#### Provenance

Official records of George Bush's presidency and vice presidency are housed at the George Bush Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

Staff Archivists, June 2006. Previously restricted materials are added as they are released.

#### **Related Collections**

Related collections may be found in the White House Office of Cabinet Affairs, the White House Counsels Office, the Council of Economic Advisers, the National Security Council, the White House Press Office, and the Office of Public Liaison, as well as the SP (Speeches) category of the White House Office of Records Management (WHORM).

#### **Scope and Content**

The materials in FOIA 2006-0892-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2006-0892-F contains materials from agencies and individuals including the National Security Council, Secretary of State James Baker, the Department of Justice, and the Office of Management and Budget. The materials cover the Presidential Determination with respect to the waiver of the Jackson-Vanik Amendment of the 1974 Trade Act with respect to the Soviet Union, tracking the progress of Executive Order 12740 from beginning to end.

White House Office of Records Management (WHORM) Subject File categories contain correspondence; memoranda; news clippings; and brochures from the general public, Congress, and the Bush administration. WHORM Subject File FO003-02 concerns mutual security and WHORM Subject File TA contains material related to trade.

#### System of Arrangement

Records that are responsive to this FOIA request were found in one collection area—Bush Presidential Records: WHORM Subject Files. As policy, WHORM Alphabetical Files and WHORM Subject Files are processed at the document level; whereas, Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of documents assigned a letter/number combination and filed in a subject category.
