Access

Collection is open to all researchers. Access to Bush Presidential Records, Bush Vice Presidential Records, and Quayle Vice Presidential Records is governed by the Freedom of Information Act (FOIA)(5 USC 552 as amended) and the Presidential Records Act (PRA)(44 USC 22) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

Copyright

Documents in this collection that were prepared by officials of the United States government as part of their official duties are in the public domain. Researchers are advised to consult the copyright law of the United States (Title 17, USC) which governs the making of photocopies or other reproductions of copyrighted material.

Provenance

Official records of George Bush's presidency and vice presidency are housed at the George Bush Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

Processed By

Staff Archivists, June–July 2006. Previously restricted materials are added as they are released.

Related Collections

Related material may be found in FOIA request 1998-0205-F entitled "Presidential Appointment of Federal Judges."

Scope and Content

The materials in FOIA 2006-0927-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2006-0927-F contains materials that are located within Bush Presidential Records: White House Counsels Office. The first folder is from C. Boyden Gray's Meeting File and contains a memo, White House correspondence tracking sheet, letter to C. Boyden Gray, and another copy of the initial memo. The second folder is from Mark Paoletta's Subject File and contains a one page personal letter from Michael B. Wallace to Mark Paoletta. The third folder is also from Mark Paoletta's Subject File and contains a 14 page Legal Services Corporation (LSC) speech, a two page letter/resume that was originally sent to Sonny Montgomery and eventually forwarded to Mark Paoletta, a one page fax cover sheet attached to the letter/resume, and finally another copy of the initial 14 page LSC speech. Note that various FOIA exemptions do apply and some of these materials may be fully closed and/or only partially open.

System of Arrangement

Records that are responsive to this FOIA request were found in one collection area—Bush Presidential Records: Staff and Office Files. As policy, WHORM Alphabetical Files and WHORM Subject Files are processed at the document level; whereas, Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.
