#### **Extent**

5 folders

#### **Access**

Collection is open to all researchers. Access to Bush Presidential Records, Bush Vice Presidential Records, and Quayle Vice Presidential Records is governed by the Freedom of Information Act (FOIA)(5 USC 552 as amended) and the Presidential Records Act (PRA)(44 USC 22) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

#### **Copyright**

Documents in this collection that were prepared by officials of the United States government as part of their official duties are in the public domain. Researchers are advised to consult the copyright law of the United States (Title 17, USC) which governs the making of photocopies or other reproductions of copyrighted material.

#### **Provenance**

Official records of George Bush's presidency and vice presidency are housed at the George Bush Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

#### **Scope and Content**

The materials in FOIA 2006-1150-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2006-1150-F contains materials from the George Bush Vice Presidential Staff and Office Files related to Catholic issues and concerns during the George Bush Vice Presidency.

The Staff and Office Files contain correspondence, memoranda, and publications maintained by individual staff members and offices. The files of Philip D. Brady, Vice President Chief of Staff, consist of memos from Philip Brady, Doug Wead, Debbie Hutton, and Thomas Melady. Some of the materials from Thomas Melady are closed under PRM restrictions. Thomas Melady acted as an advisor to Vice President Bush during the Presidential Campaign of 1988. Other memoranda and letters contain letters written by the Vice President to influential Catholic figures regarding public policy and Catholic concerns.

### **System of Arrangement**

Records that are responsive to this FOIA request were found in one collection area—Bush Vice Presidential Records: Staff and Office Files. The Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of documents assigned a letter/number combination and filed in a subject category.
