## **Scope and Content**

These Bush presidential records relate to White House Counsels Office, Mary Beth Riordan Files. These materials are arranged into three specific sub-series: Alphabetical Name Files, Noriega Research Files, & Miscellaneous Subject Files.

The Alphabetical Name Files consist of letters and published materials. The vast majority of the letters originate from the public, commenting on the Bush administration's stance regarding both foreign and domestic policies. Other letters are directed to White House Counsel from both federal employees and constituents seeking recommendations for government positions, or inquiring about potential

employment within the various executive branch offices. There are also published articles providing background information on various topics.

The Noriega Research files consist of letters, notes, memos, and database printout coversheets which are specifically related to Manuel Noriega and/or the Bush Administration's decision to send troops into Panama. The letters commend the Bush administration for a job well done. The notes and memos are primarily correspondence between Counsels Office staff members regarding compilation of documents relating to Noriega, Panama, Panamanian, Central America, and Latin America for the Department of Justice (DOJ). The coversheets are non-sensitive front jackets for database printouts.

The Subject Files consist of published reports on the regulatory reform initiatives of the Securities and Exchange Commission and the General Accounting Office's findings on policies related to the use of 89<sup>th</sup> Military Airlift Wing Aircraft by Government Officials. In addition, a published briefing and appendices for the case of Babigan v. Association of the Bar is also enclosed.
