Provenance

Official records of George Bush's presidency and vice presidency are housed at the George Bush Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

Scope and Content

The materials in FOIA 2007-0754-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2007-0754-F contains materials from the George Bush Vice Presidential Advance Office.

The Staff and Office Files contain materials used for the Advance Office Seminar and memoranda from David Ryder regarding the final draft of the Vice Presidential Advance Manual, budget information for the Advance Office Seminar, and distribution lists for the Advance Office Manual.

System of Arrangement

Records that are responsive to this FOIA request were found in one collection area—Bush Vice Presidential Records: Staff and Office Files. Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.
