#### **Extent**

7 folders, approximately 40 pages

#### **Access**

Collection is open to all researchers. Access to Bush Presidential Records and Bush Vice Presidential Records is governed by the Freedom of Information Act (FOIA)(5 USC 552 as amended) and the Presidential Records Act (PRA)(44 USC 22) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

#### **Copyright**

Documents in this collection that were prepared by officials of the United States government as part of their official duties are in the public domain. Researchers are advised to consult the copyright law of the United States (Title 17, USC) which governs the making of photocopies or other reproductions of copyrighted material.

#### **Provenance**

Official records of George Bush's presidency and vice presidency are housed at the George Bush Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

#### **Processed By**

Staff Archivists, August 2007. Previously restricted materials are added as they are released.

#### **Scope and Content**

The materials in FOIA 2007-0761-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2007-0761-F contains five selected White House Office of Records Management (WHORM) files related to Fred Krupp, Daniel Dudek, and Joseph Goffman of Environmental Defense Fund. The documents consist of coversheets and letters. The coversheets are for the purpose of forwarding letters

of correspondence throughout the White House. These letters primarily contain general correspondence of thanks between Environmental Defense Fund and the White House for a variety of reasons. For instance, one file consists of thanks from Governor Sununu to Fred Krupp of EDF for a book about environmental science. Another is a letter from EDF offering congrats for the passage of the Clean Air Amendments of 1990. There is also thanks to the administration for supporting the EPA's decision to protect the Platter River. There are also letters inviting President Bush to attend and speak at the EDF's 1991 symposium, responses of regret, and the discussion of presenting a Presidential Video Message.

In addition, there is also one selected Vice Presidential Record from the Office of Operations, Administration, Staff Secretary—Thomas Collamore Files that contains a routing sheet and a letter of thanks to Bruce Smart for sending a copy of Vice President Bush's speech on the environment.

### **System of Arrangement**

Records that are responsive to this FOIA request were found in three collection areas—Bush Presidential Records: WHORM Alphabetical Files; Bush Presidential Records: WHORM Subject Files; Bush Vice Presidential Records: Staff and Office Files. As policy, WHORM Subject and WHORM Alphabetical Files are processed at the document level; whereas, Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of documents assigned a letter/number combination and filed in a subject category. A complete listing of the subject categories including a detailed description of each category is available in our research room and on our website at <http://bushlibrary.tamu.edu/research/find/whorm/whorm.html>.
