Provenance

Official records of George Bush's presidency and vice presidency are housed at the George Bush Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

The Dan Quayle Vice Presidential Staff and Office Files contain correspondence and schedules from Vice President Quayle's National Security Affairs Office to the American Friends of Bilderberg

System of Arrangement

Records that are responsive to this FOIA request were found in two collection areas—Bush Presidential Records: WHORM Subject Files and Quayle Vice Presidential Records: Staff and Office Files. As policy, WHORM Subject and WHORM Alphabetical Files are processed at the document level; whereas, Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of documents assigned a letter/number combination and filed in a subject category. A complete listing of the subject categories including a detailed description of each category is available in our research room and on our website at http://bushlibrary.tamu.edu/research/find/whorm.html.

Please note that a single asterisk "*" indicates that the category is entirely processed and open.
