#### **Extent**

4 folders

#### **Access**

Collection is open to all researchers. Access to Bush Presidential Records, Bush Vice Presidential Records, and Quayle Vice Presidential Records is governed by the Freedom of Information Act (FOIA)(5 USC 552 as amended) and the Presidential Records Act (PRA)(44 USC 22) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

#### Copyright

Documents in this collection that were prepared by officials of the United States government as part of their official duties are in the public domain. #### **Provenance**

Official records of George Bush's presidency and vice presidency are housed at the George Bush Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

#### Scope and Content

FOIA 2008-0892-F documents preparations made for tea at the White House in honor of Great Britain's Princess Margaret on March 11, 1991. The Princess was in Washington, D.C. for the opening of the Royal Ballet in the Opera House at Kennedy Center on March 12, 1991.

The White House Office of Records Management (WHORM) Subject Files contain notes between President Bush's staff and that of Mrs. Bush proposing an event with Princess Margaret.

Staff and Office Files materials come from the White House Social Office and the First Lady's Office, Scheduling. The records of Ann Brock in the First Lady's Office, Scheduling contain notes, a biography, and guest lists used in scheduling the tea. The Cathy Fenton Files and the Laurie Firestone Files, both in the White House Social Office, are composed of guest lists and notes regarding scheduling details.

### **System of Arrangement**

Records that are responsive to this FOIA request were found in two collection areas—Bush Presidential Records: WHORM Subject Files and Bush Presidential Records: Staff and Office Files. As policy, WHORM Subject Files are processed at the document level, whereas, Staff and Office Files are processed at the folder level; that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of documents assigned a letter/number combination and filed in a subject category. A complete listing of the subject categories including a detailed description of each category is available in our research room and on our website at <a href="http://bushlibrary.tamu.edu/research/find/whorm/whorm.html">http://bushlibrary.tamu.edu/research/find/whorm/whorm.html</a>.

Please note that a single asterisk "\*" indicates that the category is entirely processed and open.
