The Bush Presidential records relate to the Committee on International Science, Engineering, and Technology (CISSET) and Intellectual Property. The documents to be opened are a form, memos, and papers. These materials consist of a Document Control form, memos from D. Allan Bromley to Ambassadors Frank Wisner and Reginald Bartholomew regarding a CISSET Study of United States Objectives for International Science and Technology and to Carla Hills regarding the United States-Indian Science and Technology Agreement, and the papers "U.S. Objectives for International Science and Technology in the Post Cold War Foreign Policy Setting" and "Statement of Roles and Objectives for the Ad Hoc Working Group of the Committee on International Science, Engineering, and Technology on Principles and Guidelines for International Science and Technology."

### **System of Arrangement**

Records that are responsive to this FOIA request were found in one collection area—Bush Presidential Records: Staff and Office Files. Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.
