Chiefs of Staff, copies of the final nomination of General Herres, official Joint Chiefs of Staff and Air Force biographies of General Herres, and official photographs of General Herres.

The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of documents assigned a letter/number combination and filed in a subject category.
