Official records of George Bush's presidency are housed at the George Bush Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

Scope and Content

The materials in FOIA 2008-1295-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2008-1295-F contains materials related to the June 1990 summit meeting between President George Bush and Soviet President Mikhail Gorbachev in Washington, D.C. These materials are substantive, policy-related documents, which include memoranda, correspondence, cables, briefing papers, transcripts, notes, and press releases. A significant portion of the material responsive to this FOIA concerns the diplomatic negotiations between Soviet and American delegations which took place prior to the summit. These negotiations dealt primarily with the control of strategic nuclear weapons and the reduction of conventional forces in Europe.

White House Office of Records Management (WHORM) Subject Categories contain memoranda, correspondence, cables, briefing papers, transcripts, notes, and press releases during the Bush administration.

The White House Staff and Office Files contain memoranda, correspondence, cables, briefing papers, transcripts, notes, and press releases during the Bush administration. A significant portion of the material responsive to this FOIA concerns the diplomatic negotiations between Soviet and American delegations which took place prior to the summit. These negotiations dealt primarily with the control of strategic nuclear weapons and the reduction of conventional forces in Europe.

System of Arrangement

Records that are responsive to this FOIA Requests were found in two collection areas—Bush Presidential Records: WHORM Subject Files and the Bush Presidential Records: White House Staff and Office Files. As policy, WHORM Alphabetical Files and WHORM Subject Files are processed at the document level. Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of documents assigned a letter/number combination and filed in a subject category. A complete listing of the subject categories including a detailed description of each category is available in our research room and on our website at http://bushlibrary.tamu.edu/research/find/whorm/whorm.html.

Please note that a single asterisk "*" indicates that the category is entirely processed and open.
