Provenance

2009-0812-F

The White House Office of Records Management (WHORM) Alphabetical Files contain a packet of letters, forms, and resumes in support of Zeda Anne Homoki's application for a position of Associate Director of the Speakers Bureau at the Department of the Interior.

The Staff and Office Files contain Zeda Elizabeth Homoki's application for an intern position with the Office of Presidential Personnel. Included are personnel forms, resumes, letters of application and recommendation, and thank you letters and postcards.

System of Arrangement

Records that are responsive to this FOIA request were found in two collection areas—Bush Presidential Records: WHORM Alphabetical Files and Bush Presidential Records: Staff and Office Files. As policy, WHORM Alphabetical Files are processed at the document level, whereas Staff and Office Files are processed at the folder level; that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

Please note that a single asterisk "*" indicates that the category is entirely processed and open.
