Collection is open to all researchers. Access to Bush Presidential Records is governed by the Freedom of Information Act (FOIA) (5 USC 552 as amended) and the Presidential Records Act (PRA) (44 USC 22) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

Copyright

Documents in this collection that were prepared by officials of the United States government as part of their official duties are in the public domain. Researchers are advised to consult the copyright law of the United States (Title 17, USC) which governs the making of photocopies or other reproductions of copyrighted material.

Provenance

Official records of George Bush's presidency, his vice presidency and Dan Quayle's vice presidency are housed at the George Bush Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

Processed By

Staff Archivists, December 2010. Previously restricted materials are added as they are released.

Scope and Content

The materials in FOIA 2009-1278-F are responsive to the topic of the FOIA.

FOIA 2009-1278-F contains materials regarding the National Environmental Policy Act (NEPA). Enacted on January 1, 1970 this legislation requires that the environment is weighed equally with other factors in the decisions of federal agencies.

The Bush Presidential materials contain an assortment of documents including correspondence to the President from private citizens and organizations, government reports, and legal documents regarding

the application of NEPA in government decisions.

System of Arrangement

Records that are responsive to this FOIA request were found in four collection areas—Bush Presidential Records: WHORM Alphabetical Files, WHORM Subject Files, and Staff and Office Files and Bush Vice Presidential Records: Staff and Office Files. As policy, the WHORM files are processed at the document level. Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

The WHORM Subject File compiled by the White House Office of Records Management and the OVP Subject File (collected by the Office of the Vice President) are comprised of a series of documents assigned a letter/number combination and filed in a subject category. A complete listing of the subject categories including a detailed description of each category is available in our research room and on our website at http://bushlibrary.tamu.edu/research/find/whorm/whorm.html.

Please note that a single asterisk "*" indicates that the category is entirely processed and open.
