Scope and Content

The materials in FOIA 2010-0107-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2010-0107-F contains materials from agencies and individuals from the Bush Presidential administration, Bush Vice Presidential Office, and the Quayle Vice Presidential Office

The White House Office of Records Management (WHORM) Alphabetical Files contain letters from the general public concerning Catholic issues and administration policies toward The Vatican and Pope John Paul II. Correspondence between the President and Dr. Thomas Patrick Melady make the largest majority of these files.

The WHORM Subject File categories contain correspondence; memoranda; news clippings; and brochures from the general public, Congress, and the Bush administration. WHORM Subject File CO170 concerns the Vatican and United States policies regarding the relationship with The Vatican.

The Staff and Office Files contain correspondence, memoranda, and publications maintained by individual staff members and offices. The Bush Vice Presidential Files contain information regarding the visit by Pope John Paul II to the United States in September of 1987.

The Quayle Vice Presidential: Staff and Office Files contain appointment information related to appointments between Dr. Thomas Patrick Melady and Vice President Quayle.

System of Arrangement

Records that are responsive to this FOIA request were found in six collection areas—Bush Presidential Records: WHORM Alphabetical Files; Bush Presidential Records: WHORM Subject Files; Bush Presidential Records: Staff and Office Files; Bush Vice Presidential Records: Name Files; Bush Vice Presidential Records: Staff and Office Files; and Quayle Vice Presidential Records: Staff and Office Files. As policy, WHORM Alphabetical Files and WHORM Subject Files are processed at the document level. Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of documents assigned a letter/number combination and filed in a subject category. A complete listing of the subject categories including a detailed description of each category is available in our research room and on our website at <http://bushlibrary.tamu.edu/research/find/whorm/whorm.html>.

Please note that a single asterisk "*" indicates that the category is entirely processed and open.
