Access

Collection is open to all researchers. Access to Bush Presidential Records is governed by the Freedom of Information Act (FOIA) (5 USC 552 as amended) and the Presidential Records Act (PRA) (44 USC 22) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

Copyright

Documents in this collection that were prepared by officials of the United States government as part of their official duties are in the public domain. Researchers are advised to consult the copyright law of the United States (Title 17, USC) which governs the making of photocopies or other reproductions of copyrighted material.

Provenance

Official records of George Bush's presidency are housed at the George Bush Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

Processed By

Staff Archivists, June 2010. Previously restricted materials are added as they are released.

Scope and Content

The materials in FOIA 2010-0606-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials. FOIA 2010-0606-F contains materials related to the November 1991 meeting of the North Atlantic Council in Rome, the meeting between Brent Scowcroft and Vatican Foreign Minister, Cardinal Tauran, and the ratification of the Conventional Armed Forces in Europe Treaty. The opened documents are declassified National Security Council cover sheets, which route classified correspondence and reports, and a letter from the Archbishop of Boston requesting that Scowcroft meet with Cardinal Tauran.

It should be noted that a significant majority of the documents listed here are security classified and have been closed under the restrictions of the Freedom of Information Act.

System of Arrangement

Records that are responsive to this FOIA request were found two collection areas – Bush Presidential Records: WHORM Subject Files, and Bush Presidential Records: Staff and Office Files. As policy, WHORM Alphabetical Files are processed at the document level. Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

Please note that a single asterisk "*" indicates that the category is entirely processed and open.
